## IT'S TIME FOR CHANGE.


Amend Section 1(b) and 1(c) of Part II of the Second Schedule of the Federal Constitution.



The Constitutional (Amendment) Bill 2023 will grant Malaysian women the right to confer automatic citizenship on their overseas-born children, on an equal basis as Malaysian men.

**We call upon all Members of Parliament from across the political spectrum to stand together with Malaysian women and vote in support of this amendment.**

- East Coast (14%)


## THE PEOPLE HAVE SPOKEN.

**There is Overwhelming Public Support for Equal Citizenship Rights for Malaysian Women.**

# 77%

agreed that Malaysian women should be granted equal rights to automatically transmit citizenship to their children born outside Malaysia, on an equal basis as men.

10% disagreed with the statement while 13% were undecided



# 77%

agreed that children born outside Malaysia to Malaysian women are Malaysians by blood and hence should be able to hold Malaysian citizenship automatically.

73% of all female respondents.



agreed that non-citizen children of Malaysian women should be able to enrol in public schools on an equal basis as Malaysian children






agreed that the existing Malaysian citizenship law needs to be amended to ensure Malaysian women have equal rights as Malaysian men to transmit automatic Malaysian citizenship to their children born outside Malaysia.

Those who agreed were:

-  75% of all Malay respondents
-  89% of all non-Malay respondents
-  77% of all male respondents
-  86% of all female respondents

8% disagreed with the statement while 11% were undecided
